I understand that Revolution Radio believes its good name was injured. I too feel my good name continues to suffer due to the near instant deletion of my efforts to clear the air.

I view the entire event as a positive. The unfolding fiasco crystallized many things. I attempted to show my motive and nature, and likewise, Revolution Radio.

I feel that management publicly accusing me of deliberate lies, or stating I live in a vehicle because of some lower socioeconomic status, on air, is a disparagement of the first order. Notwithstanding the content in chat areas.

I will be listening next Sunday (January 14) for any response (apology/clarification) you may make during your program. I made a mistake and attempted to correct it. My apology and correction were stifled. Now it is your time to entertain the larger picture.

At this time, no one has access to the offending program-audio and show-notes (with a cautionary preamble), nor the Errata page at https://proselaw.co/, containing my apology, explanation, and offer to donate \$330 in bitcoin other than (a) those hosts and listeners who have a personal connection with me via Skype, (b) those chatters who were in the chat room when I misspoke, and (c) those who reached out to me because someone captured my efforts to apologize in the chatroom and disseminated it in their own circles.

I would guess these circles encompass at least 45 people that I know of.

I asked no one in the above circles to post anything. Any postings made were self-initiated and spontaneous. Additionally, many reached out to me, and some invited me into their private rooms. These people are cognizant of my Errata page.

This issue is the elephant in the room.

I do not seek restoration of the program archives.

If you have perused the page earlier, you should be aware that I added more content and screen-scrapes.

This correspondence (this email) will not be shared, privately or publicly, and may never be seen by anyone other than the three of you listed above. This is pending the genuineness and completeness, of any public retraction by you and management's willingness to allow the posting of my Errata page in the Element and Skype host chat rooms.

I am asking for you to do the right thing and not censor/hide my efforts to apologize formally.

If you will not publicly apologize, nor direct the listeners, chatters, and hosts to my Errata page, I will post this request in the above circles. I will also incorporate it into the Errata page and remove the password protection. Releasing it into the wild. Meaning, it will not be constrained to this limited audience.

It would be nice to put this behind us and move on.

I want to thank the management of Revolution Radio for letting me use its platform. It was an opportunity to learn a new skill-set.

Returning to the positive, I consider this censoring issue to have caused a large enough brouhaha for many to take notice. Imagine Revolution Radio becomes a true beacon of free speech for the world. A force. Imagine my pleasure in saying, "I was part of that once, I am proud to have served."

We cannot be petty. We must grow. So must the station.

Currently the alchemy is out of balance.
